PRIVACY POLICY

Version 1.0.0, Updated: January 1st, 2026

OFiDCrypt (“we”, “us”, “our”) is dedicated to safeguarding the privacy and security of your personal information. This Privacy Policy outlines our practices concerning the collection, use, disclosure, storage, and destruction of your personal information when interacting with our website (ofidcrypt.com), applications, games, and other digital platforms (“Platforms”). It also applies when you register for services such as Kinconnected! Early Access, purchase products via commerce platforms, or participate in Giddy's Blinko (“Game”).

By accessing our Platforms, utilizing our services, making purchases, or registering/playing in the Game, you consent to the collection and application of your personal information as described herein.

Scope of Policy

This Privacy Policy applies to:

- **Customers/Users:** Individuals visiting our Platforms, signing up for Kinconnected! Early Access, purchasing products, or engaging with digital gifting/Web3 features.
- **Players:** Individuals registering or participating as players in Giddy's Blinko (our retro collect-to-win game).

Unless specified otherwise, all sections are applicable to both groups. Sections prefixed with “As a Player” or “As a Customer/User” pertain solely to those groups.

Personal Information Collection

Personal information refers to any data that identifies or relates to an individual, including name, email address, wallet details, etc.

We collect personal information when you:

- Visit or use our Platforms (e.g., through cookies, analytics tools).
- Register for Kinconnected! Early Access or other services.
- Create an account, profile, or connect a wallet.
- Make purchases (e.g., toys) or engage in gifting commerce.
- Communicate with us via email, social media, or Telegram.
- Participate in promotions, surveys, or provide feedback.





Types of personal information may include:

- Contact details (name, email, phone number)
- Transaction/gifting records (order history, \$XPB or \$GIDDY bonuses from our Gifting Wallet)
- Technical information (IP address, device details, browser type)
- Usage statistics (pages visited, actions performed)
- Preferences (interests, feedback)

Information may also be collected from third parties (e.g., service providers) with your consent or as permitted by law. Note that purchases or interactions via third-party commerce platforms (such as Amazon, Shopify) and affiliate redirects (for example, Kraken or Ledger) are subject to the respective platform's privacy policies; OFiDCrypt does not control their data practices.

Personal Information Collection as a Player

When registering or participating in Giddy's Blinko, we may collect:

- Contact information (name/username, email, etc.)
- Game-related data (gameplay activity, collectible items)
- Optional health/safety details for event participation (rare for digital activities)
- Emergency contact information for in-person tie-ins (if applicable)

Usernames, avatars, or gameplay highlights may appear in promotional materials or on social channels. However, users may opt out during registration or by contacting us directly, which may affect inclusion in community showcases.

Purpose of Data Collection

As a Customer/User, your information is used to:

- Provide Platform access, Kinected! Early Access, and gifting features (\$XPB/\$GIDDY bonuses)
- Communicate updates, services, and promotions
- Enhance and tailor our features
- Market offerings (with consent where required)
- Protect property rights and comply with applicable laws

As a Player, your personal information enables us to:

- Share updates and rewards related to the Game
- Manage participation and distribute bonuses
- Promote the Game and OFiDCrypt brand via highlights

Consent is obtained through registration processes and may be withdrawn at any time by contacting us.





Information Sharing Practices

OFiDCrypt does not sell or rent your personal data. Disclosure occurs under specific circumstances:

- With your explicit consent
- With service providers acting on our behalf (hosting, payment processing, wallet tools, email services), bound by agreements to safeguard your data
- With collaborators, such as GFDevSoft (independent developer for Kinnect! and Giddy's Blinko); they manage their own data obligations
- With commerce platforms (Amazon, Shopify), who manage data independently during order fulfillment
- With affiliate partners (Kraken, Ledger, or similar services) when redirected via affiliate links; data provided directly to these partners is governed by their privacy policies and not accessible by OFiDCrypt unless part of a referral program
- When required by law (e.g., provincial or federal mandates)
- In business transactions (e.g., mergers, sales), with appropriate notification

Affiliate Partnerships

OFiDCrypt participates in affiliate partnerships with third parties including Kraken and Ledger. Commissions may be earned upon qualifying purchases or sign-ups initiated by affiliate links. Partner sites independently collect personal information; OFiDCrypt receives only anonymized referral tracking and does not access or share this data. Please consult partner privacy policies (e.g., Kraken: kraken.com/legal/privacy and Ledger: ledger.com/privacy-policy) for details.

Security Measures

We employ reasonable security practices including encryption, access controls, and staff training. Absolute security cannot be guaranteed; please protect your credentials and promptly report concerns.

Data Retention

Personal information is retained only as necessary to fulfill identified purposes or to satisfy legal requirements, after which it is deleted or anonymized.

Your Rights

BC's PIPA grants rights to access, correct, delete (subject to exceptions), or withdraw consent regarding your personal information. Contact us to exercise these rights; we will respond appropriately.

Policy Updates

Privacy Policy updates are communicated via our Platforms and/or email notifications. Continued use of our services signifies acceptance of revised terms.
